The ARRL Membership Services Committee will recommend that the wildly successful Hiram Percy Maxim 125 Birthday Celebration of last September be reprised, same time in 1995 (from Labor Day weekend through the following weekend, nine days' worth). Details will be worked out over the next few months but there is strong support for more people to be eligible, namely, everyone eligible for an "ARRL Badge," which adds ARRL-VEC volunteer examiners, assistant emergency coordinators, HF and VHF awards managers, and more.

Reminder that effective December 20th, portions of Part 97 will be amended and come into effect. Details on those rules amended will appear in next months OSCILLATOR space permitting.

2400-MHZ COMMENTS DATE SET

The FCC has set December 19, 1994, as the comment date for a Notice of Proposed Rule Making to convert a block of spectrum from federal government to commercial use, including parts of the 2400-MHz band shared by Amateur Radio on a secondary basis with the government.

The League will be commenting further on this NPRM.

The proposal would allocate 2390 to 2400, 2402 to 2417 (both shared by amateurs), and 4660 to 4685 MHz, to the Fixed and Mobile Services. The FCC is required by the Omnibus Budget Reconciliation Act of 1993 to adopt rules for such reallocations by February 10, 1995.

The full text of the NPRM, released by the FCC on November 8, is available from ARRL Headquarters on the HQ BBS, at 203-666-0578, and also from the ARRL Internet InfoServer, info@arrl.org (see October 1994 QST, page 43). The file name is FCC94272.txt.

The reply comment date on the NPRM is January 3, 1995.

TESTING FEES GOING UP!

Effective January 1, 1995, the FCC's maximum allowable reimbursement fee for an amateur operator license will be \$5.92, up from the current \$5.75. The ARRL VEC will charge \$5.90 to each applicant (other than applicants taking only Elements 1A or 2).

NOTICE TO ALL TECHNICIAN CLASS LICENSE HOLDERS

If you hold a Technician class license issued before March 6, 1991, then you automatically are a Technician licensee with HF privileges (a "Tech Plus"). In some recent instances the FCC has processed the renewal or modification of such a Tech Plus license but has mistakenly issued a "Technician" (no-code) license. (Since June 8, 1994, new and renewed Tech Plus licenses have been clearly labeled as such). If this has happened to you, do the following: Write to the FCC, explaining the situation, including your current license status, with effective date. Include copies of both your "before" and "after" licenses. If you no longer have either a copy or the original of your previous license, say so in your letter. Send this to FCC, 1270 Fairfield Road, Gettysburg PA 17325-7245 (or fax 717-337-1541). Keep copies of all your correspondence with the FCC. Expect the matter to take four to six weeks to be resolved. In the meantime, you may continue to exercise "Tech Plus" privileges.

AMSAT Help Sought in Connection with Arctic Expedition

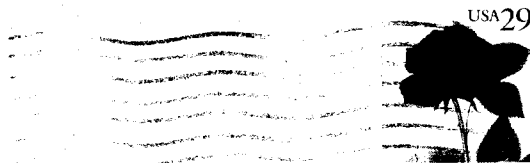
Next March, a team of six will set off on a four month trek from Russia to Canada across the North Pole. The group will be under the leadership of Will Steger, a veteran polar explorer. Others include a Russian, an American woman, a British citizen, a Dane and a Japanese woman. The group will use a combination of dogsleds and specially designed canoe-sleds to negotiate the snow covered ice and open water that will be present as the ice breaks up later in the season. If successful, they will be the first to ever cross this expanse of the Arctic in a single season. Departing the Russian island of Severnaya Zemlya March 5th, the team hopes to observe Earth Day, April 22, at the North Pole and complete the last two thousand mile leg to Resolute by July.

The purpose of the expedition is to study the environment of the Arctic, especially the effects pollution has had on it. They plan to keep in touch with school students in various parts of the world using a combination of the various store and forward Amateur Radio satellites and the Internet.

To support this ambitious undertaking, called the International Arctic Project, or IAP; AMSAT is looking for volunteers willing to work with the expedition planners and help them set up and check out the necessary communications gear. An immediate need, is someone in the Minneapolis/St. Paul area familiar with working the digital satellites, who can instruct a few IAP people in the use these birds.
